EXECUTIVE ORDER NO. 100 Series of 2020

AN ORDER DECLARING BLOCK 6, GAWAD KALINGA, PUROK 7, BARANGAY 9, MALAYBALAY CITY UNDER LOCALIZED LOCKDOWN AND FOCUSED CONTAINMENT/COMMUNITY QUARANTINE TO PREVENT, CONTAIN AND MITIGATE THE IMPACT OF THE COVID-19 CONTAGION IN THE AREA

WHEREAS, Sec. 16 of the Local government Code of 1991 mandates Local Government Units to, among others, promote the health and safety of their constituents;

WHEREAS, President Rodrigo Roa Duterte through Proclamation No. 922 s. 2020, declared a state of public emergency due to the rapid proliferation of COVID-19 in the country;

WHEREAS, the city government has consistently supported the programs of the national government in the fight against COVID-19 by closely collaborating with the concerned government agencies, the other local government units, including the barangays and the private sector in the adoption of appropriate programs and measures intended to prevent the possible local transmission of the disease;

WHEREAS, three (3) new cases of COVID-19 in Purok 7, Barangay 9, Malaybalay City were confirmed on September 05, 2020 by the Department of Health Regional Office No. X;

WHEREAS, there is a need to lockdown the residence of cases nos. 35, 37, 38 and 39 located at Block 6, Gawad Kalinga Housing, Purok 7, Brgy. 9, this City and its adjacent houses in Purok 7, Barangay 9, Malaybalay City in order immediately prevent, contain and mitigate the impact of the COVID-19 infection in the area;

WHEREAS, prior coordination with the Department of Health had already been sought for immediate technical assistance and guidance to appropriately manage the urgent situation in the locality;

NOW, THEREFORE, I, JAY WARREN R. PABILLARAN, Acting City Mayor of the City of Malaybalay, Province of Bukidnon, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. LOCALIZED LOCKDOWN. The residence of COVID 19 positive cases nos. 35, 37, 38 and 39 and its adjacent houses in Purok 7, Barangay 9, Malaybalay City is hereby placed under localized lockdown and focused containment / community quarantine whereby movement (incoming or outgoing) of all persons within the area is strictly restricted starting midnight of September 6, 2020 until further notice.

SECTION 2. ZONING CONTAINMENT STRATEGY. In implementing the localized lockdown, the Zoning Containment Strategy which is a localized rapid response operation to contain the spread of COVID-19 as a preventive option for intervention shall be adopted as follows:

- a. The lockdown area shall be categorized into the following four (4) zoning classifications:
- 1) Critical Zone – residence of COVID 19 positive case nos. 35, 37, 38 and 39;
 - 2) Containment Zone – Two blocks consisting of 20 households adjacent to the residence of the new positive cases of COVID-19 in Gawad Kalinga, Purok 7, Barangay 9, Malaybalay City near the residence of the three positive cases;
 - 3) Buffer Zone – All other houses in Gawad Kalinga Housing, Barangay 9, Malaybalay City;
 - 4) Areas Outside Buffer Zone – All other puroks of Barangay 9, Malaybalay City.
- b. The zoning classifications shall be applied to the following:
- 1) Residence of COVID-19 positive cases nos. 35, 37, 38 and 39 - ECQ
 - 2) Houses adjacent to residence of positive cases in Block 6, Purok 7, Brgy. 9, this City – MECQ
 - 3) Gawad Kalinga Housing, Purok 7, Barangay 9 – GCQ
 - 4) The rest of Barangay 9, Malaybalay City - MGCQ

SECTION 3. OBSERVANCE OF HEALTH PROTOCOLS. All government and private facilities/establishments allowed to remain open shall strictly enforce standard health protocols such as social distancing, wearing of face masks, gloves and other personal protective equipment, and adopt skeletal staffing, among others required by the Department of Health.

SECTION 45 ENFORCEMENT. The City Joint Task Force Corona Virus Shield composed of the Philippine National Police, Bureau of Fire Protection, the City Health Office and the Barangay Officials and personnel of Barangay 9 are hereby directed to strictly enforce this Executive Order.

Failure to abide by this Executive Order shall be meted with appropriate action in accordance with relevant laws and regulations. The City Legal Officer is instructed to initiate appropriate charges against violators.

SECTION 6. EFFECTIVITY. This order shall take effect immediately and shall be implemented for fourteen (14) days from September 06, 2020 (12:01 am) to September 20, 2020 (12:01 am).
